Fee	Description	Amount	Due Date
Registration	Non-refundable annual fee secures enrollment and covers startup costs.	\$30.00 for the first child; \$20.00 for each additional child of the same family.	Upon registration. Runs Sept. 1st-Aug. 31st.
Escrow	Last month's (June's) tuition.	Equal to one month's tuition payment.	Upon registration
Monthly Tuition	Monthly fee for service.	See fee schedule in Parent Handbook.	1st of each month
Late Payment	Payments made after 6PM on the 10th of each month will be subject to a late payment fee.	\$30.00	Assessed on the 11th of the month. Due with late payment.
Returned Check	A fee charged for checks returned by the bank for insufficient funds. In addition to replacement check of equal amount.	\$25.00	With replacement check
A.M. Drop-in	1-day tuition rate for morning session. Charged to accounts who do not pay a monthly fee, or those who "drop-in" on a non-scheduled morning.	\$16.50 per morning session (per child/no discounts)	Net 10 days
P.M. Drop-in	1-day tuition rate for afternoon session. Charged to accounts who do not pay a monthly fee, or those who "drop-in" on a non-scheduled afternoon.	\$20.00 per afternoon session (per child/no discounts)	Net 10 days
Cancellation Fee	Fee charged when a child is absent, when scheduled to attend, as a drop-in.	\$5.00 (per child/no discounts)	Net 30 days
Emergency Drop-in Fee	Fee charged when a child arrives at BASREP, by mistake, on a non-scheduled day.	\$10.00 (per child/no discounts), provided the child is picked up within 20 minutes of arrival.	Next Billing Cycle
Failure To Report Absence	Fine for repeated violations (in excess of 3) of BASREP's Attendance Policy (PM Program Only).	\$5.00 per occurrence	Next Billing Cycle
Break-in-Service	Guarantees re-enrollment to children after a leave of absence of longer than 8 weeks.	\$25.00 per child	Upon disenrollment
Late Pickup	Fee charged when parents are late (after 6:00 P.M.) in picking up their children.	\$5.00 per each 5 minute increment (or portion thereof). Per child/no discounts.	Next Billing Cycle
Professional Days	Surcharge for children who attend the all-day program.	\$26.00 (per child/no discounts) \$42.00 (per child/no discounts) for drop-ins.	Next Billing Cycle
Vacation Days	Surcharge for children who attend the all-day program.	\$26.00 (per child/no discounts) \$42.00 (per child/no discounts) for drop-ins.	1st day that the child attends during that week.
Early Dismissal Days	Surcharge for children who attend any portion of the early dismissal.	\$10.50 per child/no discounts. \$30.50 per child/no discounts for drop-ins.	Next Billing Cycle Drop-in's
Planned Delayed Openings	Surcharge for children who attend any portion of the planned delayed opening	\$10.50 per child/no discounts. \$27.00 per child/no discounts for drop-ins.	Next Billing Cycle Drop-in's
Weather-related Early Dismissals	Surcharge for registered children who attend the program on a weather-related early dismissal, if they were not previously scheduled to attend on that afternoon.	\$12.00 (per child/no discounts)	Next Billing Cycle
